

CONTRACTING PARTY (CP) UNDERSTANDS THE FOLLOWING:

10. If CP fail to provide their own music for incorporation in their video by two (2) weeks before their wedding date GWD will use instrumental music to which it owns the rights or no music at all. CP will assume full responsibility for Copyrighted music and other material that they provide or ask to be incorporated in their final video.
11. If CP fails to provide their own photographs for incorporation in the "Photo Montage" portion of their video by two (2) weeks before their wedding date a "Photo Montage" will not be included in their Wedding video. Instead GWD will compensate CP with two (2) copies of the edited video. No monetary compensation or refund will be made.
12. Failure to schedule and complete the taping of "Romance History" footage prior to the Wedding date may resulting the finished video being comprised of one (1) videotape containing the "Romance History" and one or more different videotapes to contain the rest of the wedding video. Copies of separate "Romance History" videotape will cost an additional \$25.00 above the cost of the Wedding video copies.
13. If CP fails to provide their own photographs for incorporation in the "Honeymoon Montage" portion of their video by two (6) weeks after their wedding date, the "Honeymoon Montage" may not be included in their Wedding Video. If the "Honeymoon Montage" is included from the video, GWD will compensate CP with two (2) copies of the edited video. No monetary compensation or refund will be made.
14. Coverage by videographers of your wedding day if described as "unlimited" is defined as no specific limit of time of hours of service. However coverage is restricted to 30 minutes before professional photography begins and concludes with the completion of those reception events identified to occur by client in Addendum A.
15. GWD reserves the rights to determine what is necessary and appropriate coverage in order to produce a video that is consistent with its production style and technique. In retaining that right GWD will determine where, how and when videographers, cameras and lighting and sound equipment will be utilized.
16. CP accepts all details of communication and execution of this agreement as are delineated in the GWD Policies and Procedures.
17. Production of the video will be completed approximately eight (8) weeks from the wedding date or eight (8) weeks from the date GWD receives any overdue payments, information or materials needed to produce the wedding video in whole or in part, whichever is later. Any guarantee of delivery sooner than eight (8) weeks must be in writing, signed by GWD and will constitute a "Rush" order. Rush orders will be completed in the time stated per written agreement for an additional fee of 15% of original cost of service. If the deadline of items (1), (12) and/or (13) are not met then there can be no guaranty of any specific time period for completion of the video. Completion of the video will occur as GWD production schedule allows.
18. CP declares that they do not make or will not make any profit in any way by using the final video or it contents. All rights for the footages or the editing of the final video belong to GWD and they are not to be use in any way without GWD approval.
19. GWD do not accept "demo to follow". However we will try to follow the CP instructions as long as they do not come in contrast with GWD original style and technique.
