CONTRACTING PARTY (CP) AGREES TO THE FOLLOWING:

1. Provide Goldenwest Digital (GWD) with any and all photographs, materials and music they want to be incorporated in their video along with completed Contract Addendums at least SIX (6) weeks before Event day.
2. If contracting party does not comply with item one (1) above, GWD is excused from producing affected segments of the video or allowed to produce them as GWD prefers or substitute affected segments with other options of GWD's choice.
3. Insure GWD crew have access to all areas and location of the event venues as is necessary to fulfill their responsibilities. GWD is not responsible for results when hindered by imposed restrictions and/or physical limitations beyond our control.
4. Addition coverage is not a guaranteed provision but is based on GWD availability and is provided at the rate of \$100.00 per hour, per videographer. Also NO guarantee of a specific videographer has been made .
5. Production of the video will be completed approximately 8 weeks from the wedding day ,if and only if item (1) above has been fulfilled.
6. Payment of fees to be as follows:
 - a). Retainer of \$_____, due this date is non-refundable assurance that GWD will reserve their Services for CP as described herein. GWD liability is limited to any monies paid in advance of the Event date should mechanical/electronic failure, theft, accident, weather or other mishap occur which prevents fulfillment of our agreement.
 - b). Balance of payment is due THREE (3) weeks prior to Event date, and must be received when due to guarantee fulfillment of contract. Amount of balance indicated below represents the cash discount price, balance paid for by credit card is as much as 5% higher.
7. It is agreed that rights to exclusive use of all video tape footage and reproductions there from are reserved by and for GWD whether for production, promotional use or otherwise.
8. Any CP requests delineated on the contract or addendums will be given every consideration, but no requests are guaranteed.
9. CP assumes all responsibility and liability for copyrighted material to be incorporated in the video.
